This Fertilizer, with Dursban® Insecticide, combines the highest quality ingredients available on a uniform corn cob base to give equal distribution of all particles over lawn area for uniform growth, and is non-burning when used as directed.

### DIRECTIONS FOR USE

For control of ANTS, BROWN DOG TICKS, CHINCH BUGS, CRICKETS, CUTWORMS, EARWIGS, SOD WEBWORMS, SOW BUGS, spread evenly at the rate of 4 pounds per 1000 square feet. Water lawn using 30 gallons per 1000 square feet, after application. For Chinch Bugs in New Jersey-New York metropolitan area, make first application in June. In other areas consult your local state agricultural extension agent as to the exact timing.

SPREADER SETTINGS: Cyclone 4; Scott 4; Lawn Beauty 4½

For control of HYPERODES WEEVIL, apply as above except at twice the rate, or 8 pounds per 1000 sq. ft. Apply over suspected problem areas in mid-April and again in mid May.
