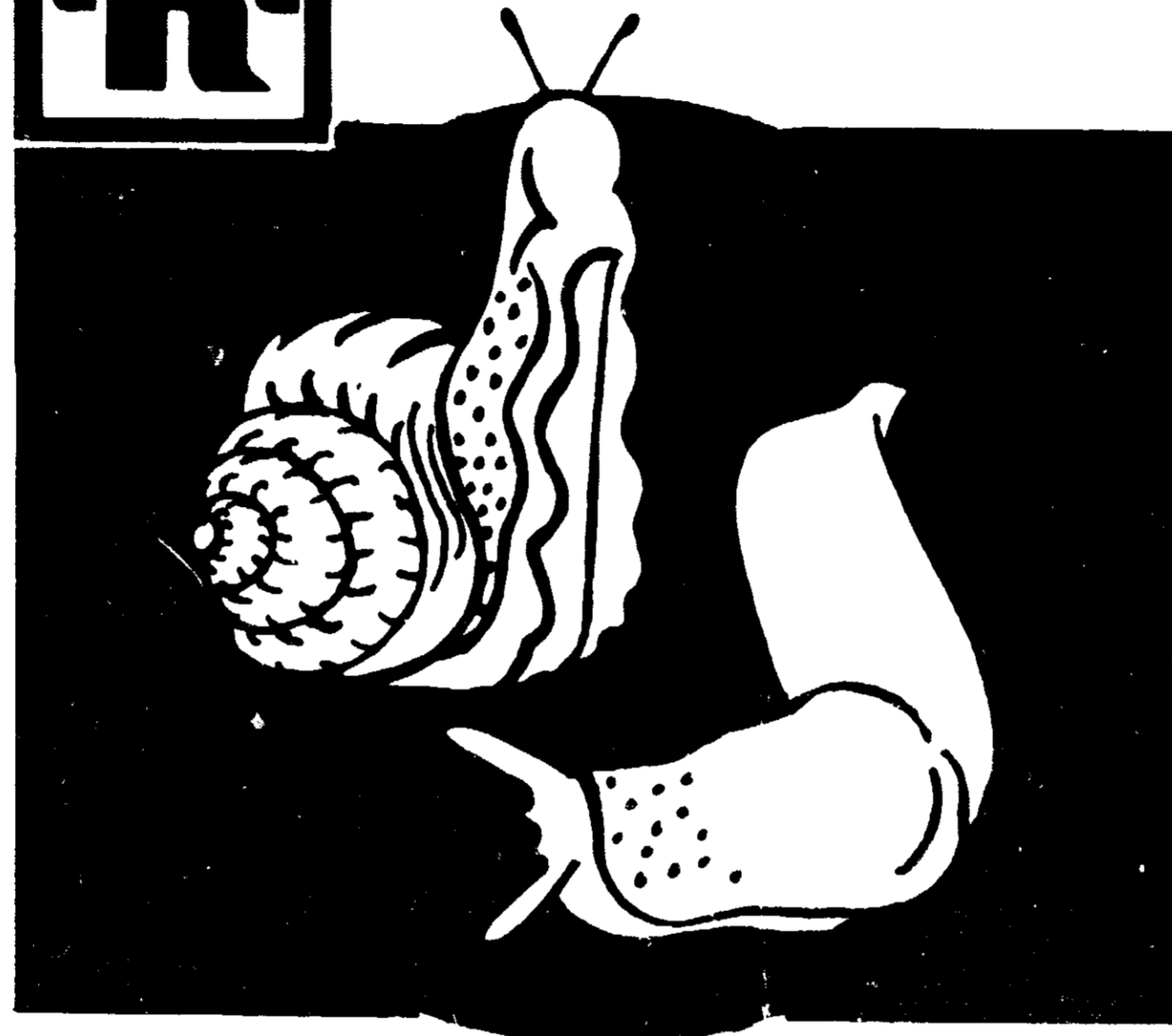

DIRECTIONS FOR USE

ROCKLAND SNAIL & SLUG "M" BAIT is very effective for the control of slugs and snails around the home, in flower gardens, and in ornamental greenhouses. The bait should be applied to soil around plants but not directly to plant foliage. CAUTION: Do not use around food crops. Sprinkle 1 pound of SNAIL & SLUG "M" BAIT uniformly over 1,000 sq. ft. of area to be treated. Do not put bait in piles. Scatter bait so that it is hardly visible on the ground. For best results lightly water the area to be treated before applying the bait. When making applications, special attention should be given to treating areas around flower beds, under greenhouse benches and around building foundations. Repeat applications as necessary to keep areas free of slug and snail pests.
