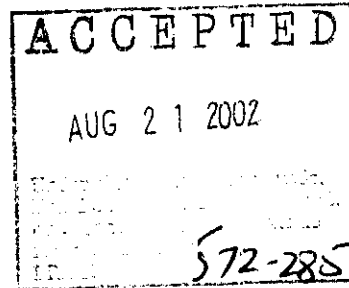

HAZARDS TO HUMANS & DOMESTIC ANIMALS

FIRST AID	
Have the product container or label with you when calling a poison control center or doctor, or going for treatment	
If in Eyes:	-Hold eye open and rinse slowly and gently with water for 15-20 minutes. -Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. -Call a poison control center or doctor for treatment advice.
If Swallowed:	-Call poison control center or doctor immediately for treatment advice. -Have person sip a glass of water if able to swallow. -Do not induce vomiting unless told to do so by the poison control center or doctor. -Do not give anything by mouth to an unconscious person.
If on Skin or Clothing:	-Take off contaminated clothing. -Rinse skin immediately with plenty of water for 15-20 minutes. -Call a poison control center or doctor for treatment advice.
If inhaled:	-Move person to fresh air. -If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. -Call a poison control center or doctor for further treatment advice.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This insecticide may be used on indoor and outdoor plants throughout the growing season, or as a preharvest treatment when other insecticides are prohibited due to residue restrictions and use limitations.

To control insects named, apply this spray as a mist (adjust nozzle by turning in order to deliver a fine mist) to thoroughly cover upper and lower leaf surfaces. Repeat treatments weekly or as needed to control infestations. May be applied on day of harvest. Do not spray when temperature exceeds 90°F.
