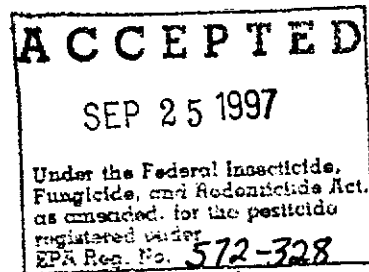

### PRECAUTIONARY STATEMENTS

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS: CAUTION:** Harmful if swallowed, inhaled or absorbed through skin. **KEEP OUT OF REACH OF CHILDREN.** Avoid breathing of spray mist and skin contact; wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco products. Do not use on household pets or humans. Do not permit persons or pets to go on or touch treated areas until the spray is completely dry. Avoid contamination of feed and foodstuffs. Do not smoke while using. Cover all fish tanks, (shut off oxygen supply.) remove all pets before beginning treatments.

**PHYSICAL OR CHEMICAL HAZARDS.** Do not Use, Pour, Spill, or Store Near Heat or Open Flame.

### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Do not use as a space spray. All food processing surfaces, exposed food and utensils should be covered during treatment or thoroughly washed before use. **ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS AND CRICKETS** --Spray heavily in all cracks around baseboards. Use on localized areas infested with these pests. Repeat as necessary. **BROWN DOG TICKS** --Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets, and localized areas of floors and floor coverings. Application should be repeated as infestations warrant and as reinfestations occur. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH THIS FORMULATION.**

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Store unused material in closed, original container only in a locked storage area out of reach of children and animals. **DISPOSAL:** To avoid harming aquatic organisms in rivers and other surface water, do not pour this product, spray mixture or rinse water into sanitary drains, (for example, toilets and sinks) or storm water sewers (for example, street drains). Triple rinse the empty container, pour the rinse water into the sprayer and spray the treated area. If disposal of a partially full container is necessary, take the container to your local household waste disposal facility, or make sure cap is tightly closed, securely wrap it in several layers of newspaper and discard in trash.
