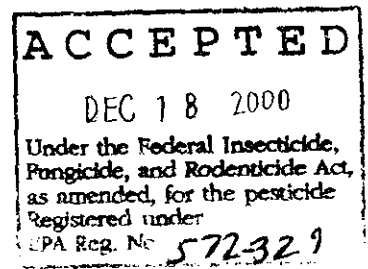

Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label. This product is highly toxic to bees exposed to direct treatment or residues on plants. PESTS INDOORS in INDUSTRIAL AND MANUFACTURING PLANTS:

GENERAL INFORMATION: Use "LO" Insect Spray to control the pests indicated in the areas listed below by application of the product as undiluted spray (0.5% chlorpyrifos). Repeat the treatment as needed.

Do not apply spray of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard. Do not allow spray to contact food, feedstuffs, or water supplies.

APPLICATION WITHIN NONFOOD AREAS OF INDUSTRIAL and MANUFACTURING PLANTS and WAREHOUSES ONLY: For Spot Treatment

Only.--Apply as a coarse spray or with a paint brush to localized areas where cockroaches (including strains resistant to certain other insecticides), ants, clover mites, crickets, firebrats, silverfish, and spiders are found or normally occur including dark corners of rooms and closets; cracks and crevices in walls; along and behind baseboards; beneath and behind cabinets(non-food storage only); around plumbing and other utility installations.

For ants apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

NOTE: A period of 4 to 7 days is normally required for maximum effect on cockroaches.

For control of fleas and brown dog ticks, thoroughly apply as a spray for spot treatment of infested areas such cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present..

Outdoor Pests Around Industrial Plant Sites, Manufacturing Plant Sites, and Road Medians Only:

FLIES: For outdoor use as an aid in reducing annoyance from these insects **only around Industrial and Manufacturing Plant sites.** Spray outside surfaces, doors, screens, window frames of Industrial and Manufacturing Plant Sites, or wherever these insects may enter. Also treat surfaces around light fixtures and other places where these insects alight or congregate. Repeat as necessary.

ANTS, BROWN DOG TICKS, CRICKETS, FLEAS AND EARWIGS: For treatment of localized infestations of these insects around Industrial Plant Sites, Manufacturing Plant sites, and Road Medians where there are weeds or brushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and re-infestations occur.

STORAGE AND DISPOSAL
Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Store unused material in closed, original container only, in a locked storage area. Do not store below 32°. **DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
