b. The following information must be added in a separate paragraph at the ending of the First Aid statements.

"For additional information in case of emergency call toll free (telephone number).

- c. As per the acute toxicity review, the "Hazards to Humans and Domestic Animals" statements must be modified as specified below:
 - "Warning. Causes skin irritation. Harmful if inhaled. Do not get on skin, or on clothing. Avoid breathing spray mist."
- d. As per the toxicity review dated November 7, 2002 and the RED (Page 86), the PPE must be modified to read:

"Personal Protective Equipment (PPE)

Applicators and all other handlers must wear:

- Coveralls over short-sleeved shirt and short pants
- Socks and chemical resistant footwear

Remove mildew by scrubbing with a mixture of one quart liquid bleach in three quarts of water. Wear protective glasses or goggles and waterproof gloves. Quickly wash off mixture that touches skin. Do not add detergents or ammonia to bleachwater mixture.

APPLICATION

Stir stain thoroughly before and occasionally during use. Under normal environmental and application conditions, thinning--not required. Use at 50°F (10°C) and above. Apply uniformly with brush, pad or spray. Covers 100 to 200 square feet (9 to 19 square meters) per gallon on rough or porous surfaces.
