

Remove mildew by scrubbing with a mixture of one quart liquid bleach in three quarts of water. Wear protective glasses or goggles and waterproof gloves. Quickly wash off mixture that touches skin. Do not add detergents or ammonia to bleach/water mixture.

APPLICATION

Stir thoroughly before and occasionally during use. Under normal environmental and application conditions, thinning--not required. Use at 50°F and above. Apply informly with brush, pad or spray.
