DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons.

PREPARATION: THIS PRODUCT MUST BE APPLIED OUT-OF-DOORS TO WOOD INTENTED FOR EXTERIOR USE, NOT FOR INTERIOR USE. This product can be used for all suitable above ground applications. (Use Cuprinol® No. 10 Green Wood Preservative where any portion of the wood will be below ground.) Use on cedar, redwood, pressure-treated and most other woods. Do not apply over hardboard or particle board. Do not use on wood that will be in contact with food, feed or potable water, or where prolonged skin contact is expected. Wood may be damp but not wet and must be free of bark, mildew and any finish. May be applied immediately to new wood. Before and during use, thoroughly mix contents of can. DO NOT MIX WITH ANY OTHER PRODUCTS. DO NOT THIN. Product appears milky in the can but dries clear.

This preservative should not be applied to a mildewed surface. Test for mildew by applying 50/50 solution of bleach and water. Mildew is present if the area lightens. Spray all mildewed infected surfaces with a solution of 1 qt. household bleach and 3 qts warm water. Let stand for 30 minutes, then rinse with clean water.

Redwood and cedar contain natural extractives. To minimize extractive discoloration, apply a solution of 1 part oxalic acid and 9 parts water. Let it sit for half an hour. Then rinse with clean water.

APPLICATION: Apply by synthetic brush or spray. For best results, apply when surface temperatures are between 50°F and 90°F which will not fall below 40°F during 24 hours after application. Thoroughly cover cut ends with two coats. The more preservative absorbed by the wood, the longer and more effective the protection. If the first coat is quickly absorbed, apply a second coat at any time after the initial application has dried to the touch. Do not apply more than two coats. Treat to saturation, but be sure to pick up puddles with a brush. On initial treatment of new wood siding, two coats are recommended.

Use only one thin coat if used as primer before painting. Wait at least 24 to 36 hours after application before painting with a good quality oil-based paint or primer. During humid conditions a longer drying time may be necessary. Wait 6 to 12 months before applying latex paints or clear finishes.

We recommend that wood be re-treated within 3 years. Roofs should be retreated within 2 years. Areas subject to direct water contact or severe exposure may require an earlier reapplication.
