BEANS Downy Mildew, Rust, Anthrachose Eegin when first blossoms appear. Do not apply within 7 days of harvest.

BEETS, TURNIPS — Cercospora Leaf Spot, Downy Mildew: Do not apply within 7 days of harvest where tops are to be consumed for food.
