DIRECTIONS

The following directions are furnished by us and are believed to be of value but in no way guaranteed. This dust should be applied at the rates of 30 to 50 lbs. per acre depending on the size and spacing of the plants and the method of application. Make first application when insects or disease threaten and repeat at 7 to 10 day intervals as necessary.

BEANS: To control bean aphids, Mexican bean beetles, leaf hoppers, downy mildew, anthracnose and angular leaf spot. Do not apply within 7 days of harvest. After harvest is completed, treated forage may be fed to livestock after 1 day following treatment or cut for hay after 4 days following treatment.

BROCCOLI, CABBAGE AND CAULIFLOWER: To control aphids, imported cabbage worms, downy mildew and alternaria leaf spot. Do not apply to cabbage within 7 days of harvest and do not apply to broccoli and cauliflower within 5 days of harvest.

CUCUMBERS, MELONS AND SQUASH: To control aphids, leaf hoppers, downy mildew, anthracnose and angular leaf spot. Do not apply to summer squash or cucumber within 7 days of harvest or to winter squash or melons within 3 days of harvest.

ONIONS: To control onion thrips, botrytis leaf blight, downy mildew and purple blotch. Do not apply within 10 days of harvest.

POTATOES: To control aphids, Colorado potato beetles, flea beetles, and early and late blight. Do not apply within 35 days of harvest.

TOMATOES: To control aphids, vinegar flies (*Drosophila* sp.), anthracnose, septoria leaf spot and early and late blight. Do not apply within 3 days of harvest.
