DIRECTIONS FOR USE

Unless otherwise indicated dosage rates are in quarts of Alfa-Spray in sufficient water to cover one acre. Thorough full coverage applications should be made: Aerial Applications - approximately 3 to 10 gallons of water per acre consistent with crop growth have been accepted as the minimum quantity needed for airplane application. Ground Equipment - approximately 25-50 gallons of water per acre as the minimum quantity consistent with the equipment manufacturer's recommendation to insure thorough full application.

ALFALFA: For control of alfalfa weevil, spittlebug, leafhopper and aphid.

FIRST CUTTING: Apply 2-3 quarts per acre as soon as weevil damage appears in the field. Early application is desired to control the weevil when they are small. Do not apply within 7 days of harvest. Do not apply to alfalfa in bloom.

STUBBLE SPRAYING: In areas where weevil appears at cutting time. Remove the first cutting and apply 2-3 quarts per acre to the stubble to control weevil larvae and aphid.

SECOND and SUBSEQUENT CUTTINGS: Apply 2 to 3 quarts per acre to control alfalfa weevil, leafhopper and aphid as these insects appear. Do not apply within 7 days of harvest of any cutting.
