## HOW TO USE PURINA POULTRY DUSTING POWDER

## AS A LITTER TREATMENT

To Control Northern rowl Mites, Chicken Mites, Lice, Fleas, and Bedbugs: Apply Poultry Dusting Powder to the litter at the rate of 1 pound to 40 square feet with a hand or power duster. For small areas, use a scoop or scatter by hand. Distribute dust evenly. Also dust roosts and adjacent areas. Avoid direct contamination of eggs. Do not treat nest litter. Repeat as necessary.

## FOR DIRECT APPLICATION TO BIRDS

To Control Northern Fowl Mites, Chicken Mites, Lice and Fleas; Individual treatment: Shake Poultry Dusting Powder into the feathers, particularly around the vent, neck, and breast regions. Ruifle the feathers so that the powder can reach the skin. Use 1 pound per 100 birds. Repeat dusting in 4 weeks, if necessary. Hand application to birds for chicken mite and fleas is a supplement to litter treatment for control of these pests.

Caged Poultry: Use Poultry Dusting Powder in a hand duster. Hold nozzle so it touches the feathers and apply one puff to both the vent and breast areas. Use 1 pound per 100 birds. Repeat dusting in 4 weeks, if necessary.

CHICKEN DUST BATH BOXES

To Control Northern Fowl Mites, Chicken Mites, Lice, and Fleas: Use 2½ pounds of Poultry Dusting Powder in a shallow box for 50 birds. This is a supplement to litter treatment for chicken mite and flea control. On ranges, 2 natural wallows may be substituted for each dust bath box.

Do not dust birds (or litter) within 7 days of slaughter.

**CAUTION:** 

HARMFUL IF INHALED OR SWALLOWED

Do not breathe dust. Do not take internally. Avoid breathing of dust.

Skin contact may be harmful; avoid contact. Wash hands before eating. Take shower or bath after work. Wear regular long sleeved work clothing. Change to clean clothing daily. Avoid contamination of feed, food containers and water.

KEEP OUT OF REACH OF CHILDREN AND ANIMALS.

Note for physician: Carbaryl is a moderate, reversible cholinesterase inhibitor. Atropine is antidotal.

Do not reuse empty container. Destroy it by burying with waste or burning. Stay away from smoke or fumes.


