

Treat roosters carefully and thoroughly to avoid reinfestation in breeding flocks. For positive control of mites on roosters dipping may be desirable.	Roost Paint Fowl Tick (Blue Bug)	1% 1%	Use 1 pint to 100 feet. Apply thoroughly with brush or sprayer, especially to cracks. L 1 gallon for 100 to 150 sq. ft. Apply thoroughly to walls, ceitings, floor cracks and crev- ices with power sprayer.




