**Grama Det Ticks:** Remove dog from area. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product.

**Elies and Mesquitees** Use only out of doors is an aid in reducing annoyance from these insects. Spray outside surfaces of Window and door frames, dark corners and under eaves of porches, patios and garages.


