Loafing Sheds, Livestock Pens, Pig Parlors, Stables, Broiler Houses. Use only, around outside areas. Scatter FLY PATROL at the rate of 1 lb per 1000 sq. ft. on ground areas where flies congregate. Ideal baiting sites are around doorways, outside of fence lines, soiled areas, or in alleyways of feedlots. Place bait on clean paper if fleers are limed.

Gaged Poultry and Turkeys on Wire: Scatter FLY PATROL on walkways at the rate of \$\frac{1}{4}\$ lb per 500 sq. ft. to aid in controlling house flies. Also scatter outdoors around doorways.

<u>Dog Kennels and Furbearing Animal Units:</u> Scatter FLY PATROL around outside areas of dog pens, runways, and other surfaces out of reach of the animals. For cage units, scatter on walkways at the rate of ½ 1b. per 500 sq. ft.

Food, Poultry and Meat Processing Plants: Scatter FLY PATROL at the rate of 1 lb per 1000 sq. ft. in inedible department only. FLY PATROL may be used outside livestock pens or loading and unloading docks.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool, dry area in original container.
