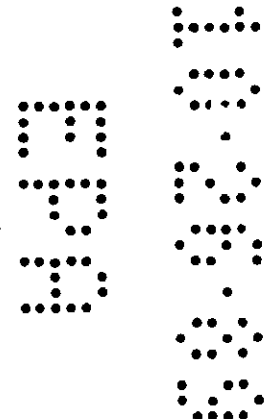

Cockroaches, Ants, Silverfish, Spiders, Crickets: Spray into cracks and corners, beneath and behind cabinets, refrigerators, sinks and stoves, behind baseboards, around doors and windows, along foundation, around garbage and waste containers, and other localized areas where pests may occur. Spray ant trails and places where ants may enter.

Brown Dog Ticks: Remove dog from area. Spray infested areas such as bed and resting quarters, nearby cracks, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present.
