Dogs and Cats: Dilute at the rate of 3 ounces in 1 gallon of water. For rapid control of ticks, fleas, and lice, sponge or dip solution on entire animal, thoroughly wetting the skin. Avoid contact with pet's face and eyes.

Do NOT treat kittens or puppies less than four weeks old.

AS MIST SPRAY

For rapid control of ticks, fleas, and lice with a mist spray:

Dilute at the rate of 1 ounce in 9 ounces of water. To insure thorough coverage, part the fur by stroking against the lay of the hair as spray is applied. Spray ticks directly. Apply to moisten the fur lightly.

AS PREMISE/YARD SPRAY

To Control Insects in Kennels and Animal Quarters:

Dilute at the rate of 1 ounce in 10 ounces of water.

Remove pets before treating the area and ventilate thoroughly before allowing them to re-enter the treated area.

For rapid cleanout of fleas and ticks in kennels, apply with a good machine adjusted to deliver coarse droplets. Apply to the point of runoff, with special attention to cracks and crevices and other insect hiding places. Bedding should be removed and sprayed thoroughly.
