To kill accessible stages of granary and rice weevils, Indian meal moths, Mediterranean Flour Moths, flower moths, angoumois grain moths infesting stored food product areas. Clean all areas to be sprayed. To spray food storage areas, remove food products from shelves and racks. Spray thoroughly, replace food, spray light mist that will fall upon packages. For sacked food, spray between and around packages. Contact as many weevils as possible. After all local areas have been sprayed, close windows and doors. Thoroughly fog the entire storage area, being extremely careful that all food products are covered. Do not remain in treated areas and ventilate the areas after treatment is completed. After 10 to 20 minutes, sweep up and destroy all fallen insects. Repeat once a week or when reinfestation becomes evident.


Infested stored food products should be fumigated or treated by other effective methods using products approved for fumigating stored food.

CAUTION! This is a combustible mixture and should not be sprayed near an open flame. Do not spray directly into food stuffs. Do not reuse container. Destroy when empty.

Food should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas apply only when the facility is not in operation.

Do not breathe spray mist. Wear mask or respirator of a type recommended by the U.S. Bureau of Mines to give adequate protection against this material. Wash hands, arms, and face with soap and water after handling and before eating or smoking. Wash all contaminated clothing with soap and hot water before reuse.
