DIRECTIONS

FOR USE ON INSECTS INFESTING GRAIN BINS, FLOUR MILLS, AND GRAIN ELEVATORS

To Kill Exposed or Accessible Stages of Grain Weevils, Grain Mites, Caddisflies, Saw-toothed Grain Beetles, Flour Beetles and other insects in empty bins: After bin has been emptied of grain, sweep bin down completely and remove all dust and tailings from bottom of bin. Start spraying at bottom of bin and work up to top, applying spray to point of run-off. Pay particular attention to any cracks or crevices in the bin. Be sure the spray is forced into these cracks. In the case of large bins an electric sprayer may be attached to a pulley and lowered in the bin and then rotated to insure adequate coverage. Depending on the surface to be treated, one gallon usually covers 750-1,000 sq. ft. Allow the bin to dry completely before refilling.

For Control of Roaches, Silverfish, Flour Beetles, Spiders, and Ants in Food Establishments and in Warehouses: Apply as a coarse spray to baseboards, around plumbing fixtures, under skids and motor mounts, around base of equipment, around window frames and sills. To control ants, spray ant trails thoroughly also. Be sure to force spray into all cracks and crevices in walls, ceilings and floors. Spray all areas where insects can enter building. Apply to point of run-off (750-1,000 sq. ft. per gallon, depending on surface.) Repeat treatment as necessary.

CAUTION

Do not apply spray directly to food products. Avoid excessive inhalation of spray mist or contact with skin or eyes. Do not spray or store contents near fire or flame. Keep container tightly closed. This product will be harmful if swallowed. Keep away from children.

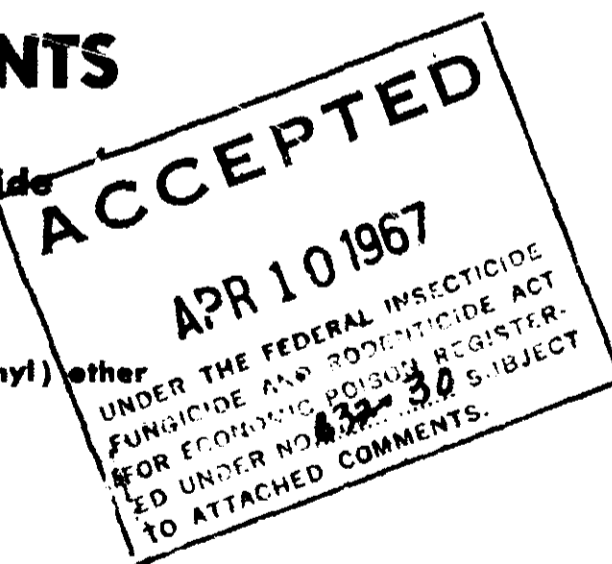

FOR CONTROL OF FLIES, MOSQUITOES, GNATS, FLYING MOTHS AND SIMILAR INSECTS

To control these insects close all windows and doors to the room and apply spray as a fine mist directed toward the ceiling and corners. Apply at the rate of one ounce per 1,000 cubic feet of space. A good electric spray, steam vaporizer or heat-generating fogger can be used with this spray. Hand sprayers can also be used. Room should be filled with mist and remain closed for 10 to 20 minutes after spraying. Crawling insects which are directly contacted by this spray will be killed. Removal of the fallen dead insects after spraying and sanitation as well as spraying around the breeding places of the insects, will help in their control.

Use in food processing plants only when plant is not in operation. All food processing surfaces should be covered or thoroughly cleaned before using.
