DIRECTIONS FOR USE

APPLES — For the control of Black Rot (fruit and foliage), Fly Speck, Sooty Blotch, Bitter Rot, Brooks Spot, Apple Blotch, Botry — Osphaeria Spot and Black Pox — Apply 35 to 40 pounds per acre during pre-bloom, calyx, and early cover dustings. Whenever weather conditions favor disease, shorten the interval between applications. 5% Thylate Dust is a protective fungicide;

hence, applications are most effective when made in advance of infection periods.

Good coverage of foliage and developing fruit is required for best results.

PEACHES — Brown Rot — For blossom blight, apply at 3 to 4 day intervals during bloom at a rate of 40 pounds per acre, timed to keep newly opened blossoms covered. For fruit rot, apply at petal fall and 2 weeks later. Make one or more additional applications at 7 day intervals beginning about one month before harvest, or earlier if rot is apparent on green fruit.

Rhizopus Rot — Apply as directed for fruit phase of brown rot.

Scab — Apply at petal fall at the rate of 40 pounds per acre, and repeat 3 to 6 times at 10 to 14 day intervals or until disease is well under control. Do not apply within 7 days of harvest.

STRAWBERRIES — For control of gray mold (Botrytis) — Use at the rate of 40 lbs. per acre. Make 3 to 5 applications at ten-day intervals, beginning at early blossom stage. Good coverage of strawberry buds, blossoms and developing fruit is required for best results.

If applied within 3 days of picking, remove residues by washing.

CAUTION
