TOMATOES: Early blight, late blight, Septoria leaf spot, gray leaf spot (Stemphylium) anthracnose, leafhopper, serpentine leaf miner, whitefly and aphids. Apply when fruit of first clusters is well formed or when insects first appear, at the rate of 20 pounds per acre. Repeat at 7 to 10 day intervals. (Do not use on young seedlings in greenhouses as injury, \leq may occur.) When weather conditions favor disease, more frequent applications may be necessary, starting when plants are set in fields.
