- d. In the section labeled "statement of practical treatment (first aid)" the most severe routes of exposure should be listed first. Move the "INGESTION" directions to the first item in the list before "EYES."
- e. In the section labeled "Directions for Use" delete the following three statements as they pertain to the application of an end-use product while 644-150 is a manufacturing use product.
 - (1) Delete "Do not apply this product in such a manner that drifting will expose workers, other persons or animals."
 - (2) Delete "Do not enter area without protective clothing until product has dried."
 - (3) Delete "Oral and/or written warnings should be given in a language customarily understood by workers handling this product."
- f. In the section labeled "Directions for Use" change the following wording to emphasize that this is a manufacturing product and can not be sprayed directly on a site:
 - (1) Change "1. For uses on: " to "1. For formulating products to be used on: ".
 - (2) Change "2. For uses for which USEPA ..." to "2. For formulating products for uses for which US EPA"
 - (3) Change "3. Uses for experimental ..." to "3. For formulating products for experimental"
- 2. Submit three copies of the revised final printed label for the record before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
