The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following changes and submit one (1) copy to us before you ship your product:

1. Revise your Ingredient Statement as follows:

Active Ingredient	
Naphthalene	99.95%
Inert Ingredients	<u>0.05%</u>
TOTAL	100.00%

2. Change "Statement of Practical Treatment" to "First Aid".
3. All text must be at least 6 point. See attached sheet for other minimum requirements.
4. Add the following two sentences to your "WARNING":

Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

5. Under the "Application Directions", change "2 feet" to "4 feet".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

TO KILL CLOTHES MOTHS:

Use Restrictions: To kill eggs, larvae, adults of clothes moths in clean, air-tight containers (e.g., chests and trunks), garment bags, and storage closets. Do not use in containers, dry cleaning and garbage bags, or closets that allow vapors to escape into occupied rooms. Do not use this Naphthalene-containing product with any other moth control chemical. For use only on cloth containing wool or wool blends.

Pre-Application Directions: Before storing, dry clean, wash or brush articles to be protected.

Application Directions: Apply product in clean, air-tight containers, bags and closets listed above at the following rates:

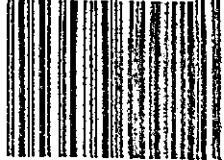
Pounds of Product	Area of Tightly Enclosed Space
1/2	Average Garment Bag
1	Large Trunk
1	50 Cu. Ft. (Small Closets)

For larger closets, multiply the height, width, and depth of the space and divide by 50 to determine the number of pounds of product needed. For example, a closet 8 feet high, 2 feet wide, and 3 feet deep (i.e. 48 cubic feet) would need about 2 pounds of product (48/50=1.9).

Post Application Directions: Keep product in air-tight space for a minimum of seven (7) days. Odor dissipates when treated articles are aired.

Retreatment: Since moths are active all year, replenish air-tight containers, bags, and closets 2 times a year.
