

Arab Wasp and Hornet Spray contains a formulation of insecticides especially designed to provide fast knock down and kill of certain stinging insects where they create a hazardous condition.

#### DIRECTIONS FOR USE

Remove protective cap and hold aerosol dispenser upright. Standing at a distance, aim away from your face directly at the target and depress the button completely. Individual insects will be killed by direct spray. For best results, however, spray the nest in late evening when the insects are less active and most of them are in the nest.

**For Nests:** Thoroughly soak the nest and its openings.

**For Yellow jackets:** Yellow jackets nest in stumps or underground. For nests in logs or stumps, soak the wood thoroughly with particular attention to places where wasps are seen to enter and leave. In cases of underground nests, direct the jet stream at the opening and thoroughly soak it.

**For Large Wasps:** These large wasps often invade lawns where the openings to their underground nests are easily seen. Thoroughly soak the openings and surrounding soil.

**For Bees:** These large bees, very similar in ap-

pearance to bumble bees, live in nests which they excavate in wood—often wood siding or trim. The round openings to the nest are about a half-inch in diameter. Direct the jet stream at the openings and thoroughly soak the surrounding wood. Repeat treatment if necessary.

**Precautions:** Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with skin. Avoid inhalation of mist. Wash thoroughly with soap and water after handling and before eating or smoking. Keep out of reach of children. Do not allow children or pets to contact treated surfaces until dry. Do not apply to humans or animals. If swallowed, induce vomiting immediately and get medical attention. Atropine is antidotal. Do not use in commercial food preparation areas or in edible products areas of food processing plants. Do not contaminate feed, water or foodstuffs. **DO NOT USE AS A SPACE SPRAY.**
