AGRICULTURAL USES: Treatment of seeds for the following agricultural crops: Barley, broccoli, brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, oats, radishes, rye, sorghum, spinach, Swiss chard, and wheat.

STORAGE AND DISPOSAL

STORAGE: If container is damaged, stop any leaks by repositioning the container or otherwise repairing the leaks.
