

AGRICULTURAL USES: Treatment of seeds for the following agricultural crops: Barley, broccoli, brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, oats, radishes, rye, sorghum, spinach, Swiss chard, and wheat.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: If container is damaged, stop any leaks by repositioning the container or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective equipment as required to prevent contact with the product or its vapors. Sweep on to a shovel and put the sweepings into a salvage drum.
