  - a. Delete the words "Keep out of lakes, streams, and ponds." Replace with "Do not add directly to water."
  - b. Delete the words "Apply artificial respiration if indicated."
  - c. In the Statement of Practical Treatment, "If in Eyes" add the words "Call a physician if irritation persists."
2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
