### DIRECTIONS FOR USE (CONT.)

**PEST INDOORS:** General information: Use as a SPOT TREATMENT to control Cockroaches, Ants, Crickets, Firebrats, Silverfish, Spiders, and Brown Dog Ticks and around Residential, Industrial, Institutional and Commercial Buildings including homes, apartment buildings, hospitals, stores, manufacturing plants.

**COCKROACHES:** (Including strains resistant to certain other insecticides) ANTS, CRICKETS, FIREBRATS, SILVERFISH, SPIDERS FOR SPOT TREATMENT apply as a coarse spray or with a paint brush to localized areas where these pests are found or normally occur, including dark corners of rooms and closets, cracks and crevices in walls along and behind baseboards, beneath and behind sinks, stoves, refrigerators, and cabinets around plumbing and other utility installations. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance. Note a period of 4 to 7 days is normally required for maximum effect on cockroaches.

**FOR CONTROL OF CARPET BEETLES:** Thoroughly apply spray as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and where these insects are seen or suspected.

**BROWN DOG TICKS:** Thoroughly apply spray as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. DO NOT TREAT PETS WITH THIS PRODUCT.

**CAUTION: (PESTS INDOORS):** Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensils and surfaces with soap and water if they become contaminated by application of this product.
