



The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicids and Modenticide Act (FIFRA), as amended, is acceptable.

The submitted Formula Statement has been added to the product's registration file.

We suggest the following two revisions to the existing Statement of Practical Treatment due to the change of solvent:

> If swallowed ~ Call a physician or Poison Control Center immediately. If possible, vomiting should be induced under medical supervision. Drink one or two glasses of water and induce vomiting by touching the back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. If in eyes - Flush eyes with plenty of water. Call a physician if irritation persists.

Please note that the remaining items of this section should appear as in the submitted labeling.

The Pesticide Disposal text should be revised so that the end reads "...according to Federal or approved State procedures under Subtitle C of the Hesource Conservation and Recovery Act."
