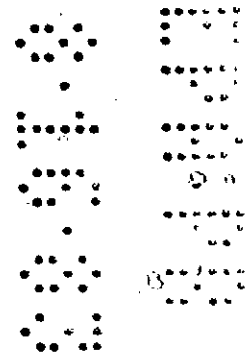

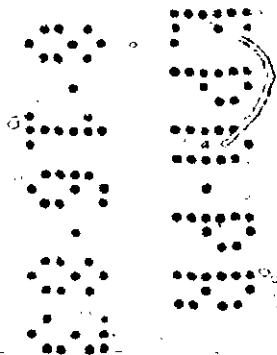

c. Add the words "if irritation persists" after the words "Call a physician immediately" in the "If in eye" statement of practical treatment.

2. Submit five (5) copies of your final printed labeling before you release the product for shipment.
