#### **STORAGE**

Note To Physician: Atropine is antidotal.

2. Revise your Environmental Hazards paragraph to read as follows:

This pesticide is toxic to wildlife. Do not discharge into lakes, streams, ponds or public water except in accordance with an NPDES permit. For further guidance, contact the nearest FPA Regional Office.

3. Revise the If In Eyes section of your Statement of Practical Treatment to read as follows:
