DIRECTIONS FOR USE

This pesticide may be used only for the formulation of an insecticide. Formulators using the product are responsible for obtaining EPA registration for their formulated product. Refer to product information sheet for formulating and other information.

This technical product may be formulated into end-use products solely for the uses listed below:

AGRICULTURAL USES: Treatment of seeds for the following agricultural crops: Barley, broccoli, brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, oats, radishes, rye, sorghum, spinach, Swiss chard, and wheat.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

STORAGE: If container is damaged, stop any leaks by repositioning the container or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective equipment as required to prevent contact with the product or its vapors. Sweep on to a shovel and put the sweepings into a salvage drum. Dispose of wastes as below.
