COMPUTATION OF ACRE - FEET:

AN ACRE FOOT is a unit of volume of a body of water having the area of one acre and a depth of one foot. To determine acres teet in a given body of water, make a series of transects across the water body taking depths with a measured pole or weighted line. Add the soundings and divide by the number made to determine the average depth. Multiply this average depth by the total surface to find the acre feet to be treated. If number of surface acres is unknown, contact your local Soil Conservation Service, which can determine this from aerial photographs.

Pre-mix with water at a rate of one gallon PRENTOX SYNPREN-FISH to 10 gal, of water. Uniformly apply over water surface or bubble through underwater lines.
