DIRECTIONS FOR USE: RAX TRACKING POWDER CAN BE USED FOR CONTROL OF HOUSE MICE, NORWAY AND ROOF RATS IN AREAS WHERE THERE IS NO POSSIBILITY OF CONTAMINATING FOOD OR SURFACES THAT COME IN DIRECT CONTACT WITH FOOD. RAX TRACKING POWDER SHOULD BE PLACED IN THE RODENTS' RUNWAYS OR AVENUES OF TRAVEL, SO THAT DUST PARTICLES ARE PICKED UP ON THE FEET OR FUR OF THE RODENTS AND INGESTED AS THE RESULT OF NORMAL GROOMING. USE 1 OZ. PER SQ. FT., AND DUSTED AREAS NEED NOT BE MORE THAN 4 INCHES WIDE AND 12 INCHES LONG. RAX TRACKING POWDER IS RECOMMENDED FOR RAT CONTROL IN INDOOR SITUATIONS WHERE CONTROL IS DIRECTED TOWARDS ROOF RATS, SPECIAL ATTENTION SHOULD BE GIVEN TO THEIR CLIMBING HABITS; THUS, THE POWDER MAY BE MORE EFFECTIVE IF PLACED WITHIN SUITABLE CARDBOARD TUBES OR WOODEN TUNNELS AND ATTACHED TO RAFTERS OR OTHER HORIZONTAL SURFACES WHERE THE RATS WILL PASS THROUGH THEM COMING IN CONTACT WITH THE POWDER. EXCESSIVE QUANTITIES SHOULD NOT BE USED. USE AT THE RATE OF ONE OUNCE PER SQUARE FOOT. TUBES SHOULD BE LONG ENOUGH THAT SPILLAGE THROUGH THE ENDS WILL BE MINIMIZED. MAKE SURE APPLICATIONS ARE INACCESSIBLE TO CHILDREN AND PETS.
