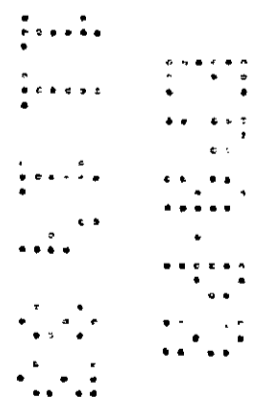

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
