#### WARNING

If it is necessary to induce vomiting, give victim one or two glasses of water and insert finger in back of throat. Do not induce vomiting or give anything by mouth if person is unconscious or convulsing.

If inheled, remove victim to fresh air and apply artificial respiration if indicated.

If on side, wash promptly with soap and water. Rinse thoroughly.

If in eyes, rinse eyes with plenty of water and call a physician immediately.

Note to Physician: This product is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine. This product contains a xylene range aromatic solvent which may present an aspiration hazard. Gastric lavage may be indicated if product was taken internally.

#### Environmental Hezards

This product is highly toxic to birds, fish and other wildlife. Birds, especially waterlowl, feeding or drinking on treated areas may be killed. Because of the migratory habits of Atlantic Coast waterlowl, do not apply this product to lawns in Nassau County, New York between November 1 and May 20. Do not exceed maximum permitted label rates. Rates above those recommended significantly increase potentia: hazards to birds and waterlowl. Avoid overlapping of sprays.
