For control of cockroaches, ants, silverfish spiders, crickets, earwigs and brown dog ticks. Use in and around homes, apartments, garages, similar residential structures, institutions, restaurants and food processing plants. Use outdoors as an aid in reducing annoyance from flies and mosquitoes entering homes.

**DIRECTIONS FOR USE: (Cont'd)**

**FOOD AREAS - APPLICATION LIMITED TO CRACK & CREVICE TREATMENT ONLY** Includes areas for receiving, storage, packing, canning, bottling, wrapping, boxing, preparing edible waste storage and enclosed processing systems (mills, driers, edible oils, syrups) and serving areas when food is exposed and facility is in operation.

To control roaches, ants, earwigs, waterbugs, silverfish spiders and crickets, apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housings, junction or switch boxes. Prior to application, de-energize electrical equipment. After application, allow time for oil to evaporate before starting motors or placing switches in ON position. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contaminating of food or food processing surfaces.

**APPLICATION OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT IS NOT PERMITTED**

**SERVING AREAS** Facilities where foods are served, such as dining rooms, but excluding areas where foods may be prepared or held, apply as a spot treatment to selective surfaces such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed)

**DIRECTIONS FOR HOUSEHOLD AND OUTDOOR USE IN NON-FOOD AREAS** Including garbage rooms, lavatories, floor drains, floor entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage (after canning or bottling). Apply to baseboard areas around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets, and similar areas where insects hide or through which they may enter. Repeat treatment as required.

**BROWN DOG TICKS** Apply thoroughly as a spot treatment to infested areas, such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product.

**FLIES & MOSQUITOES** Use only on outdoor surfaces. Spray outside surfaces of windows and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages, where these insects may congregate. Flies & mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

**STORAGE AND DISPOSAL**

**1. Prohibitions** DO NOT CONTAMINATE WATER, FOOD OR FEED BY STORAGE, DISPOSAL OR CLEANING OF EQUIPMENT. OPEN DUMPING IS PROHIBITED.

(Places other than private residences where prepared or served, held, processed, prepared or served)

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.  
Open dumping prohibited.

**STORAGE:** If container is damaged: STOP any leaks by repositioning the container or by patching or otherwise repairing the leaks.
