

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION

STORAGE AND DISPOSAL

Use as a spot treatment to control cockroaches, silverfish, spiders and other pests specified below. Apply as a coarse (large droplet) spray to localized areas where pests may occur. Spray surfaces until wet. Re-treat as needed.

COCKROACHES, CRICKETS, SILVERFISH, SPIDERS:

Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and doors and around window frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. In treating individual kitchen cabinets, all dishes and food should be removed before spraying. Replace only when spray dries. Repeat as necessary.

ANTS: Spray areas where these pests are found. In addition for ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

BROWN DOG TICKS: To control these pests, thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices along and behind baseboards, window and door frames and localized areas of floor and floor coverings, where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.**

FLIES AND MOSQUITOES: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames, as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

USE PRECAUTIONS

DO NOT allow children or pets to contact treated surfaces until spray has dried.

DO NOT spray air in rooms or use on plants. Apply as a surface spray only as specified on this label.

DO NOT allow spray to contact food, feedstuffs or water supplies. Thoroughly wash dishes and food handling utensils, if contaminated with this product.
