Subject: Deletion of Unsupported Malathion Uses Prentox Malathion 50% EC EPA Reg. No. 655-598

The labeling amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you:

Submit one copy of your final printed label incorporating the following corrections before you release the product for shipment.

1. Since all indoor uses have been removed from the label, the following indoor use cautionary statements need to be deleted from the label:

"Use only with adequate ventilation. After using this product indoors, ventilate thoroughly before occupying enclosed spaces."

2. The directions and claims for use against household pests must be revised/qualified as described below to avoid inadvertent use of the product indoors.

a. Qualify the front panel claim for use against "certain household insects" to read, "certain household insects outdoors only".

b. In the use direction table, qualify the claim for household pests" to read: "household pests outdoors only".

c. Qualify the heading, "To control household pests" to read: "To control household pests outdoors."

d. In the same paragraph described in item 2.c. above, 1) delete the following treatment sites which imply indoor use: the directions for use on baseboards, shelving, storage surfaces, storage localities and basement areas; and 2) correct the statement, "Selected surfaces around ___" to read: "Selected surfaces around the outside of ___".

Regarding your Confidential Statement of Formula (CSF) for the subject product, the most recent submitted CSF in our file for the product which is dated December 9, 1992 is acceptable.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended label constitutes acceptance of this condition.

A stamped copy of the label showing use on apples and pears is enclosed for your records. Please note, that, as stated in the enclosed copy of the Agencys March 28, 1998 letter, IR-4 has subsequently picked up the commercial use of malathion as an emulsifiable concentrate on apples and pears. We appologize for any confusion regarding the use of malathion on these crops.
