Labeling Submitted February 12, 1999

The labeling amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable, provided that you:

- A. Submit one copy of your final printed label incorporating the following corrections before you release the product for shipment.
- 1. Add the use of protective eyewear to the protective clothing statements for applicators, other handlers and for early entry into treated areas to reflect the change in category toxicity for eye irritation.
- 2. Since all indoor uses have been removed from the label and the stored grain facility use has been added, the indoor use cautionary statements need to be qualified to read somewhat as stated below so as to avoid inadvertent use of the product for any other indoor use.

"Use only with adequate ventilation. After using this product in stored grain facilities, ventilate thoroughly before occupying enclosed spaces."

- 3. Relocate the indoor precautionary statements from their present location in the Environmental Hazards section to the human precautionary labeling section.
- 4. The directions and claims for use against household pests must be revised/qualified as described below to avoid inadvertent use of the product indoors.
 - a. Qualify the front panel claim for use against "certain household insects"

to read, "certain household insects outdoors only".

b. In the use direction table, qualify the claim for household pests" to read: "household pests outdoors only".

- c. On page two in the paragraph headed, "To control household pests", qualify the heading to read: "To control household pests outdoors."
- d. In the same paragraph described in item 4.c. above, 1) delete the following treatment sites which imply indoor use: the directions for use on baseboards, shelving, storage surfaces, storage localities and basement areas; and 2) correct the statement, "Selected surfaces around __" to read: "Selected surfaces around the outside of __".
- B. Submit the public copy of your data matrix prior to releasing the product for sale or within 30 days of this letter, whichever is sooner. Please refer to the enclosed copy of PR Notice 98-5 for the need to submit a public copy of your data matrix.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended label constitutes acceptance of the conditions.
