

For Dormant Use - To control scale insects red soider mites and mealy bugs on Dormant shrubs, or evergreens (note caution*f. Woody Plants, Fruit Trees (apple, plums, pears, apricots, peaches, cherries) and shade trees: Use 1/3 pint (5-1/3 ozs.) per gallon water.

*Do not spray foliage within 30 days before or after using sulfur. Do not spray broadleaved evergreens when temperatures are near or below freezing. Dormant oil spray may cause discoloration of Blue Spruce. Do not apply oil when rain or snow is likley to follow quickly or when the temperature is below 40° F., or is likely to drop to the freezing point before the spray has thoroughly dried. Use the proper amounts only as stated on this label and follow all cautions. Spray thoroughly, wetting insects on both sides of leaves. δ
