STORAGE AND DISPOSAL

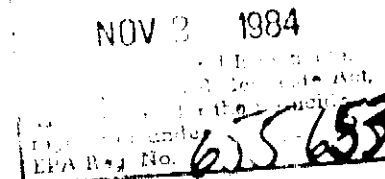
