### STORAGE AND DISPOSAL

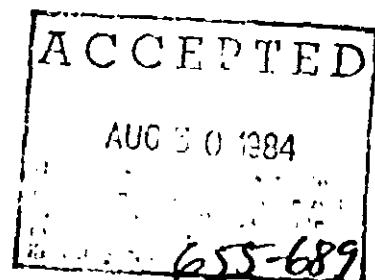
