For control of fleas and ticks on easts and dogs, dilute 1 oz. of concentrate with 40 ozs. of water. Work rinse into fur and wash out with water. The rinse should be allowed to remain on the animal 5 minutes before rinsing it off.

REAPPLICATION DIRECTIONS


Do not reapply for 7 days.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

STORAGE: If container is damaged: Stop any leaks by repositioning the container or by patching or otherwise repairing the leaks. Take care to avoid contact with pesticide and wear protective gear.
