Presitions For Use (cont'd)

Use a 0.5% emulsion prepared by diluting 5 , ounces of 12.5% Lindane to one (1) gallon of water or 2712 ounces to 5 gallons of water For treating support wood (beams timber etc.) in attached porches, outside buildings and storage areas in and around the home, barns and other existing structures apply as a coarse spray until surfaces are well Brush emulsion onto small areas. Do not apply coarse spray in living areas. Do not apply as a mist Best results are obtained when applied to dry wood.

Use in the home is limited to protessional licensed Past Control Operators only Donot use in poultryhouses. Du not use in dairy barns and milk rooms. Remove animals from barns, and nover all feed and water troughs before spraying twiceings. Do not use on animals. Do not use on humans or household pets. The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

1. A Symptoms of Poisoning section must be added to the label in close proximity to the STATEMENT OF PRACTICAL TREATMENT; we suggest the following:

"SYMPTOMS OF POISONING: headache, nausea, dizziness, loss of equilibrium, muscle spasms, difficulty in breathing, hyperexcitibility and convulsions."

2. Be sure to note the type size requirements of the front panel signal word, the "KEEP OUT OF REACH OF CHILDREN" and the headings "RESTRICTED USE PESTICIDE" and "STORAGE AND DISPOSAL".

Submit five (5) copies of your revised final printed labeling before you release the product for shipment with the amended labeling.

A stamped copy of the label is enclosed for your records.

If you hold a Federal registration, a supplemental registration, or a Special Local Needs registration, you may continue to produce new stocks of such products, using current labeling, until April 1, 1984. After that date, all remaining inventories of affected products will fall under the Existing Stocks provisions stated in our letter of October 28, 1983.
