Dear Mr. Miller:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to your label:
 - a) Because this product is intended for home garden use as well as commercial agricultural use, you must add the USER SAFETY REQUIREMENTS box as outlined in the Agency letter dated 10/1/96. Please change the title of the box to HOME GARDEN USER SAFETY REQUIREMENTS in order to avoid confusion with language required in the Worker Protection Standard. Add the following to the Directions for Use:

HOME GARDEN USER SAFETY REQUIREMENTS

Wear long-sleeved shirt, long pants, shoes plus socks and household latex or rubber gloves when applying this product.

Change clothing as soon as possible after use.

Wash the outside of gloves before removing. As with any pesticide product, wash hands thoroughly immediately after handling and before eating, smoking or using the toilet.

b) To the VEGETABLE INSECT CONTROL section of your label, add the following directions for home garden use:

"DIRECTIONS FOR HOME GARDEN USE: Wearing household latex or rubber gloves, use a dust applicator such as a shaker can, dust gun, puffer or other bulbous duster, rotary duster or other appropriate duster as available. Dust lightly to cover both upper and lower leaf surfaces with a thin, even film of dust. Apply when air is calm to avoid drift and contact with eyes and skin. Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Allow dust to settle in treated areas before reentering. For plants above chest height, consider using a liquid carbaryl product. Do not repeat application more than once a week."

- c) In the Directions for Use on OKRA, change "...5 to 7 day intervals..." to "...7 day intervals..."
- d) In the ORNAMENTAL INSECT CONTROL section, delete "...unless shorter interval is specified below."
- e) In the Directions for Use FOR CONTROL OF ANTS, change "Repeat as necessary" to "Repeat as necessary but not more than once a week."
- f) In the Directions for Use on DOGS AND CATS, change "...less than four weeks of age" to "...less than 12 weeks of age."
- 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. A stamped copy of the labeling is enclosed for your records.

ENVIRONMENTAL HAZARDS

This product is toxic to fish and wildlife. For terrestrial uses, do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Suggested desages refer to pounds of Prentox Carbaryl 10D per acre. Where a desage range is indicated, use lower rate on young plants, higher rate on mature plants. Use sufficient dust to obtain full coverage. Apply when insects or their damage appear. Repeat at 7 to 10 day intervals, or as necessary, unless shorter interval is specified below.

BEANS: Green Beans, Lima Beans, Snap Beans, Cowpeas & Blackeyed Peas: Use 5 lbs. per acre (2 ozs. per 1,000 sq. ft.) for Mexican Bean Beetle: 10 lbs. per acre (3½ ozs. per 1,000 sq. ft.) for Bean Leaf Beetle, Cucumber Beetles, Flea Beetles, Japanese Beetle, Leafhoppers, Velvet-bean Caterpillar, and Western Bean Cutworm. Use 10 to 15 lbs. per acre (3½ ozs. to 5½ ozs. per 1,000 sq. ft.) for Armyworms, Corn Earworm, Stink Bugs and Tarnished Plant Bug. IN CALIFORNIA: Use 20 lbs. per acre (7 ozs. per 1,000 sq. ft.) for Corn Earworms, Lima Bean Pod Borer, Lygus and Stinkbug.

CUCUMBERS, MELONS, PUMPKIN AND SQUASH: Use 5 to 10 lbs. per acre (2 ozs. to 3½ ozs. per 1,000 sq. ft.) for Pickleworm and Melonworm: 10 lbs. per acre (3½ ozs. per 1,000 sq. ft.) for Cucumber Beetles, Flea Beetles, Leafhoppers and Squash Bugs. Avoid excessive applications. To avoid possible injury on tender foliage, do not apply when foliage is wet or when rain or excessive humidity is expected during the next 2 days. Carbaryl insecticide injures watermelons in Florida.

POTATO, TOMATO, EGGPLANT AND PEPPER: Use 5 to 10 lbs. per acre (2 ozs. to 3½ ozs. per 1,000 sq. ft.) for Colorado Potato Beetle, Flea Beetle, and Leafhoppers. Use 10 to 20 lbs. per acre (3½ ozs. to 7 ozs. per 1,000 sq. ft.) for European Corn Borer, Fall Armyworm, Lacebugs, Tomato Fruitworm, Tomato Hornworm, Tarnished Plant Bugs and Stinkbugs.

OKRA: Use 10 to 20 lbs. per acre (3½ ozs. to 7 ozs. per 1,000 sq. ft.) for Corn Earworms and Stinkbugs. Repeat at 5 to 7 day intervals, or as necessary.

SUBSEQUENT PLANTING OF FOOD AND FEED CROPS IN TREATED SOILS MUST BE MADE WITH CROPS ON THIS OR OTHER CARBARYL LABEL(S).

ORNAMENTAL INSECT CONTROL

Sufficient dust should be used on each plant so that the upper and lower leaf surfaces are thoroughly covered. This product can be used to control insects or ornamental plants. Specific plants and insects are listed below. Repeat at 7 to 10 day intervals or as necessary unless subster interval is specified below. Recommendations below are for treatment of individual plants.

ROSES: Apply dust to upper and lower leaf surface for control of Rose Aphid, Rose Sing, Thrips and Plant Bugs.

PYRACANTHA: Apply dust to upper and lower leaf surface for control of Lacebugs.

NOTE: Carbaryl insecticide does not control spider mites. Where infestations are encountered, use a recommended miticide. Carbaryl insecticide injures BOSTON IVY.

HOUSEHOLD INSECT CONTROL

GENERAL DIRECTIONS FOR USE: Do not apply where children are likely to come in frequent contact with treated surfaces. Do not contaminate food, food containers or cooking utensils. Do not use in edible products areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Apply dust only in sufficient quantity to produce a fine light coating. If applied too heavily, excess dust will tend to repel insect pests.

FOR CONTROL OF ANTS: Apply Carbaryl 10D to ant entrance locations such as door sills, around window frames and sash, pipe into structure entrances etc. Dust ant trails and hills. Repeat as necessary.

FOR CONTROL OF FLEAS AND BROWN DOG TICKS ON PREMISES: Thoroughly dust all infested areas with Carbaryl 10D including cracks and crevices in woodwork, floors and floor coverings, and animals sleeping quarters. Repeat as necessary. Do not repeat applications more than once a week.

Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth and genital areas. Rub or brush pet's hair to work dust down to the skin. This product should not be applied by children. Avoid treatment of Do not use on kittens or puppies less than four weeks of age. Do not use on pregnant dogs. Repeat at weekly intervals if needed.

IN AND AROUND DOG AND CAT QUARTERS: For Ticks and Fleas, wearing household latex or rubber gloves, dust bedding, liberally in and around sleeping quarters, kennels and dog houses by means of a shaker can, hand or power duster or other dust applicator. Do not repeat application more than once a week. Force dust into cracks and crevices. Repeat as necessary:
