Prentox ® D + 2 Insecticide

Your Submission Dated May 8, 1995

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling:

1. Add "Do not apply by air" and "Do not treat more than five application sites per day and do not make applications more than once per week" to the Directions for Use.
2. Add the following protective clothing statements to directions: "Persons who handle this product must wear coveralls worn over short sleeved shirt and short pants, socks, chemical resistant footwear and gloves."

What are the container sizes for this product? Is this product in child resistant packages (CRP)? The product meets both the toxicity criteria and use criteria for CRP. It would be exempt from CRP if it is marketed in container sizes 5 gallons or greater. Other wise the package needs to be in CRP.

Submit two copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

WARNING: Do not take internally. May be fatal if swallowed, inhaled or absorbed through the skin. Do not get in eyes, on skin or on clothing. Wash after handling. This product is toxic to fish, birds, and other wildlife. Birds feeding on treated areas may be killed. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water when disposing of equipment washwaters. Use only as specified on this label.

PHYSICAL AND CHEMICAL HAZARDS

Do not use, pour, spill or store near heat or open flame.

STORAGE AND DISPOSAL

PESTS OF LAWNS, AND OTHER ORNAMENTAL & RECREATIONAL TURF AREAS FOR THE CONTROL OF CHINCH BUGS, AND SOD WEBWORMS (LAWN MOTHS) ON "DIFFICULT TO WET" TURFGRASSES.

Apply D + 2 Insecticide uniformly over the turf with water according to the directions given in the following table, and apply as a coarse, low pressure spray using suitable application equipment. For best results, the lawn should be moist at time of treatment and care should be taken to obtain complete and uniform coverage of pest infested areas. Spray when pests first appear, and repeat when needed.
