- 1) You must state under the product name the intended use <u>sites</u> of the product (golf Course Turf, Road Median and Industrial Plant Sites as they were listed on page 2 of your label).
- 2) A typographical error **2DDVP**) must be corrected from the "contains...." under the list of ingredients.

Do not apply by air. Do not treat more than five application sites per day and do not make applications more than once per week.

Persons who handle this product must wear coveralls worn over short sleeved shirt and short pants, socks, protective eyewear such as goggles, face shield or safety glasses with front brow, and temple protection, chemical resistant footwear and gloves.

PESTS OF ORNAMENTALS AROUND INDUSTRIAL PLANT SITES & GOLF COURSE TURF (ONLY) & ROAD MEDIAN AREAS FOR THE CONTROL OF CHINCH BUGS, AND SOD WEBWORMS (LAWN MOTHS) ON "DIFFICULT TO WET" TURFGRASSES.

Apply D + 2 Insecticide uniformly over the turf with water according to the directions given in the following table, and apply as a coarse, low pressure spray using suitable application equipment. For best results, turf should be moist at time of treatment and care should be taken to obtain complete and uniform coverage of pest infested areas. Spray when pests first appear, and repeat when needed.

NOTE: Mosquitoes coming to rest on areas treated for control of Turf insects will be killed for varying periods of time after treatment, depending on exposure of treated areas to weathering conditions.
