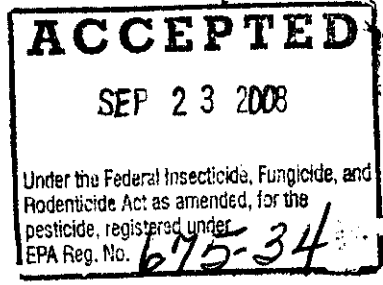

**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**TO OPEN CHILD RESISTANT CAP:** Hold bottle firmly with one hand on the flat surface. With other hand squeeze sides of cap where indicated while turning counterclockwise. Avoid squeezing bottle when opening. To reseal, turn cap clockwise until tightly closed.

**TO CLEAN, DISINFECTANT, AND DEODORIZE TOILET BOWL AND URINAL SURFACES:**

1. Flush first and remove excess dirt and grime before cleaning and disinfecting.
2. Wet all surfaces of bowl interior, including sides of bowl and under the rim with at least 4 oz. of [Professional] Vani-Sol® Per Diem® bowl cleaner (squeeze bottle approximately 15 seconds). Replace cap securely.
3. Let soak for at least 10 minutes. Do not close toilet bowl lid.
4. Brush entire bowl thoroughly with a bowl mop (especially under rim) and flush.
5. Rinse bowl mop in fresh water after use.

**TO REMOVE TOUGH STAINS:**

1. Apply a generous amount of liquid directly onto the tough stains. (For severe rust stains, if possible, remove water from bowl before applying liquid).
2. Let soak for 15 minutes. Do not close lid.
3. Brush entire bowl thoroughly with a bowl mop and repeat if necessary.

Will not harm white or colored vitreous china toilet bowls or urinals. Will not harm plumbing or septic tanks. If accidentally splashed, wash with large amounts of clean water. Do not use [Professional] Vani-Sol Per Diem on sinks, bathtubs, chrome fixtures.
