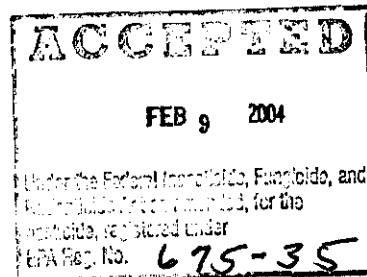

Directions for Use:

For Disinfecting:

- Preclean surfaces prior to disinfection.
- Thoroughly wet surfaces [with] [this product] [Vani-Sol Bulk Disinfectant Washroom Cleaner] using trigger sprayer or pistol grip sprayer.
- Allow contact time of 10 minutes.
- Wipe off with dry absorbent cloth or paper towel.

For General Cleaning and Deodorizing:

- For stubborn soil or heavy build-up of soap scum on shower walls, apply [this product] [Vani-Sol Bulk Disinfectant Washroom Cleaner] and allow to remain wet for 15 to 20 seconds before wiping off.

Mildewstat:

- To control mold and mildew on precleaned, hard nonporous surfaces, thoroughly wet surfaces.
- Wipe of with dry absorbant cloth.
- Repeat application at weekly intervals or when mildew growth appears.

Cleans and shines plastic surfaced desks, typewriter keys, external non food contact surfaces of vending and drinking machines and all smudged and painted hard nonporous surfaces outside the washroom.

FIRST AID
